Meet Joe Marihugh-DGD Goldmaster / Board Member

Hi, my name is Joe Marihugh. I am a current board member, the new club gold master, and gold prospecting has been my active hobby for the past 12 years. I've been a member of DGD for a little over nine years now and actively involved in club activities for the past five years.

Gold prospecting has always been an interest of mine. I remember going up to my uncle's claim, gold mining back in the mid 90s when I was a little kid and it's always stuck with me. My wife, Becky, and I try to get out as much as we can to prospect. Over the years I've made my own equipment and learned how to find the gold and read the ground. At first it was a slow start. We would find just a little bit and we would be ecstatic. But we've learned over the years, and we've really started finding good gold during the past four years. We went from 7 grams annually, to a



half ounce, then to an ounce and hoping it stays that way!

We use all types of different equipment from dry washers, to recirculating and high banking and dredging. My favorite is recirculating the high banker in the water when it is running on the claims. We've even got a detector recently and started using it and found the first gold on May 18, 2024. Our biggest nugget to date is 1.64 grams and our best day digging is 5 grams out of 20 buckets. I've found gold on all of the DGD claims, it's just a matter of learning the ground and processing the material. We like to run a lot of material when we go out, and the more you run the more you find. Some of my favorite claims are the Snoozin, Wishful and the Bruiser claims. We like to help people that are new to the gold mining as much as we can, because we know how hard it is to learn it all on our own, so we like to help people out and point them in the right direction.

In addition to our southern Arizona claims, I dig all over the state of Arizona. We like to go to Prescott and we've even gone to California and would someday like to try our hand in New Mexico, and Colorado. However, our big goal is going to Alaska for a summer. It's all about having fun with the ones you love. Get out and find the shiny!

Interesting Fact about Gold Nuggets

Here is a fun fact about gold: It is harder to find a one-ounce gold nugget than a five-carat diamond!

One of the main reasons is that the easiest gold has already been found. The numerous gold rushes that took place in the 19th and 20th centuries took advantage of the fact that very little prospecting had been done, meaning gold nuggets were much more common and much easier to find than they are today.

My Mining Tour Adventure with Jeff Williams

It has always been a dream of mine to go on a Jeff Williams mining tour adventure. Luck was certainly on my side on March 17th when the drawing was held to attend the "Greenhorns Gold" tour April 12-14 at the Meadview, AZ, claims near Lake Mead! I am certainly not a "Greenhorn" when it comes to gold mining, just not with a metal detector. I have a Gold Monster (which I had renamed "Bullet Monster") and have never found a lick of gold with it. Jeff Williams is not a cheap date and there are no guarantees that you will get any gold, but I decided what the heck and rolled the dice. A half hour after paying my money I got an email from Jeff stating I was in! I was certainly thrilled beyond belief at the opportunity to attend and immediately booked a cabin at Mike's RV Park in Meadview and the adventure was on!

April 11th arrived very quickly and it was time to head north. After a routine roadtrip, I checked into a cabin and all was good for tomorrows activities. That was it for Friday's fun and what fun it was! Everybody found gold nuggets, so we called it a day and it was off to "town" for dinner. After a good nights rest, it was back to the claims for another round of scooping up gold nuggets with the "Gold Monster," - so I thought! I got skunked pretty bad on Saturday and was disappointed, but determined to go out Sunday for our last day and get at least one more nugget. I arrived at the claims Sunday morning and using all the logic I could muster, I decided to hit the area I was at Friday as we all know nobody gets all of the gold...right? Well, I thought today should be better than yesterday, but still could not scare up any gold. So I'm hanging out with my team leader, Vee, and here comes Jeff Williams to check up on us. Vee tells Jeff that this guy (me) has been working his butt off and has not found any gold today. In typical Jeff Williams fashion, he grabs my detector and yells "Come on, let's goooo!" and takes off running up the hillside, and begins using my Gold Monster in a manner I could only describe as bizarre. If you have seen the Olympic sport of "Curling" (people frantically sweeping the ice in front of the "rock"), that is basically what Jeff

was doing. Damndest thing I ever saw. After assaulting a couple dozen Joshuas using his unique way of metal detecting, Jeff also got skunked. I had to smile because he found the nugget in someone's "tailing pile" somebody had found the target, dug it up, and totally missed the gold. Lesson learned, check those piles! Turns out that the guys with the PI (Pulse Induction) detectors continued to find gold after the VLF crowd found all the shallow easy to find nuggets.

At the "gold weigh" Sunday I would say between the 15 of us, in two days we found around two (2) ounces of nuggets and I found 5.4 grams of gold myself!

The trip was awesome and the memories I now share with my new friends is worth way more than the \$950 price of admission! Jeff is a great guy,



Metal Detecting Humor





Choosing the Right Metal Detector

If you are new to metal detecting (like I was when I jointed the club) or interested in purchasing a metal detector, you will hear about technologies like Very Low Frequency and Pulse Induction—the technology metal detectors utilize to send, receive, and interpret electromagnetic signals. The following is a comparison of the top two technologies:

Very Low Frequency (VLF) Metal Detectors operate using two distinct coils: a transmitter coil and a receiver coil. The transmitter coil generates a continuous, low-frequency magnetic field that penetrates the ground. When this magnetic field interacts with a metallic object, it induces eddy currents in the object, which in turn generates a secondary magnetic field. The receiver coil then detects this new magnetic field and produces an electrical signal proportional to the strength of the field. This signal is then sent to the control box for interpretation and display.

VLF metal detectors rely on the concept of phase shift detection to discriminate between different types of metals. Phase shift refers to the difference between the transmitted and received signals. This phase shift is influenced by the conductivity and magnetic permeability of the target metal, allowing the VLF detector to distinguish between ferrous and non-ferrous metals. By analyzing the phase shift, VLF detectors can provide information about the probable composition and size of the object.

Advantages of VLF Metal Detectors

Discrimination capabilities: The most notable advantages of VLF metal detectors is their ability to discriminate between various types of metals, allowing users to ignore unwanted targets, such as iron or steel, and focus on more valuable items like gold.

Target identification: VLF metal detectors typically come equipped with advanced electronics that can provide additional "target" information such as depth and size. Some VLF detectors have built-in visual or audio indicators that help users identify the type of metal detected, further enhancing the chances of successful finds.

Disadvantages of VLF Metal Detectors

Sensitivity to ground mineralization: VLF metal detectors are more sensitive to ground mineralization than PI detectors, which can lead to false signals and decreased performance in highly mineralized areas.

Limited depth detection: While VLF detectors are effective at finding metal objects near the surface, they may struggle to locate deeper targets. The strength of the magnetic field generated by the transmitter coil decreases with depth and limits the detection range.

Choosing the Right Metal Detector (continued)

Pulse Induction (PI) Metal Detectors operate by generating a series of short, powerful electromagnetic pulses instead of a continuous magnetic field. These pulses are transmitted into the ground using a single coil, which also serves as the receiver. When the pulse encounters a metallic object, it induces eddy currents in the target, creating a secondary magnetic field that decays over time. The decay rate is dependent on the target's conductivity and magnetic permeability.

The PI metal detector utilizes time delay measurement—measuring the time delay between the transmitted pulse and the received decay signal. The time delay information is used to determine the presence of a metallic object and estimate its depth. Since the decay rate of the secondary magnetic field is primarily affected by the target's properties, PI detectors can detect various types of metals, including those with low conductivity.

<u>Advantages of Pulse Induction Metal Detectors</u>

Depth penetration: The primary advantage of PI metal detectors is their superior depth penetration compared to VLF detectors. The powerful electromagnetic pulses allow PI detectors to locate targets at greater depths, which is particularly useful where valuable objects have been covered by layers of soil, rock, or sediment over time.

Insensitivity to ground mineralization: PI metal detectors are generally less sensitive to ground mineralization than VLF detectors and can be used in a broader range of conditions/locations without requiring frequent adjustments to ground balance settings.

<u>Disadvantages of Pulse Induction Metal Detectors</u>

Lack of discrimination capabilities: A significant disadvantage of PI metal detectors is their limited ability to discriminate between different types of metals making it challenging to avoid unwanted targets when detecting in high "trash" areas.

High power consumption: PI metal detectors generally consume more power than VLF detectors due to the high-energy pulses they generate. This increased power consumption can lead to shorter battery life and increased operating costs.

VLF and PI Detector Comparison

Detection depth

- Pulse Induction (PI) detectors generally offer the greatest depth penetration, making them ideal for locating deeply buried targets.
- Very Low Frequency (VLF) detectors provide moderate depth capabilities and are suitable for detecting objects near the surface.

Choosing the Right Metal Detector (continued)

Discrimination capabilities

- VLF detectors stand out as the most effective at differentiating between various types of metals, allowing users to focus on specific targets and ignore unwanted objects.
- PI detectors have limited discrimination abilities, which can make it challenging to avoid undesirable targets during detection.

Applications for Hobbyists/Casual Users

- VLF detectors are often the preferred choice due to their discrimination capabilities, target identification features, and ease of use.
- PI detectors are typically more popular among experienced treasure hunters with a specific focus or those searching for deeply buried items or natural gold deposits.

Initial Investment

- VLF detectors are moderately priced and offer a good balance between performance and cost.
- PI detectors are typically the most expensive, but their superior depth capabilities and insensitivity to ground mineralization can make them worth the investment for specific applications or experienced users.

Maintenance and Operation

- VLF detectors may require a little more setup and calibration but are still user-friendly, with advanced quality-of-life features that can significantly enhance your experience.
- PI detectors can be more complex to use and require a better understanding of metal
 detecting techniques, but their performance benefits may outweigh the learning curve
 for some users. Additionally, PI detectors may have higher power consumption, which
 can result in increased operating costs or the need for additional batteries during
 extended detecting sessions.

Which Detector is Best for You?

VLF and PI detectors operate on a unique system and offer distinct advantages and disadvantages. The VLF detectors excel in discrimination capabilities and target identification but can be sensitive to ground mineralization and have limited depth detection. On the other hand, PI detectors provide superior depth penetration and insensitivity to ground mineralization but lack discrimination capabilities and consume more power.


Choosing the Right Metal Detector (continued)

For those seeking a well-rounded, user-friendly detector with good discrimination capabilities, a VLF detector is the best choice. A good VLF detector will range from \$500 upwards.

For experienced users or those with specialized requirements, such as deep target detection or operation in highly mineralized environments, PI detectors may be worth the investment. Good PI machines will cost anywhere from \$1,500 to \$13,000 (or more).

Metal detectors are expensive, so it is important to ask yourself—are you just going for a day or weekend trip, an extended trip with prospecting as entertainment, or will you be spending a lot of time searching gold? These are important considerations before spending hundreds, if not thousands of dollars purchasing a metal detector.

Note: There is another type of metal detector called a **Beat Frequency Oscillation (BFO)** detector. BFO detectors are simple, affordable, and easy to use, but offer limited depth and sensitivity, along with poor discrimination capabilities. While BFO detectors are generally the most affordable option, making them attractive for beginners or those on a budget, modern BFO options are rare and they need to be purchased through second-hand marketplaces.
