Our gold master Bob Burgette reported that members garnered 14 #1 nuggets, 11 #2, and 3 #nuggets last month.


Our treasurer reported that the club was in the black last month.

#### GOLD PROSPECTING BASICS

#### **Internet Mining Claim Research**

With the growth of the internet the process of who owns which mining claim, what areas are unclaimed and which government jurisdiction controls the land that is desirable for prospecting much more efficient. It has become so efficient that it can usually be done in less time than it takes to travel to and from the government office we would traditionally visit during claim and property research.

The LR2000 system is the Bureau of Land Managements (BLM) searchable database for public reports on federal land and mineral use authorizations, conveyances, mining claims, withdrawals and classifications. This website enables users to access the same information over the Internet as in the BLM State Office Information Access Centers.

As prospectors we are interested in mining claim recordation which contains information on unpatented mining claims located on federal lands including claimant name, approximate location, and other applicable information. Mineral patents are not contained in Mining Claim Recordation. Claims marked active are currently held by a person or group with all the proper paperwork filed and all fees paid by the required date. Those marked "case closed" are open to have a mining claim placed over the area described.

To access claim information enter the address: https://reports.blm.gov/reports.cfm? application=LR2000 which will take you to the Land and Mineral System Reports. Scroll down to Public Mining Claims Reports. You will see a number of search options, probably the most important are claim name/number index, customer info(claim holder), geo index and geo report. When you click and open one of the search options a group of values must be entered, **The system will not accept any entries that are not made in capital letters**. Examples on entering Median, township rang and sections coordinates are shown above the value categories that need to be filled in if the Geo report option or geo Index option are being used. The meridian codes for each state are as follows: AZ-4, CA-15, CO-06, ES(eastern states)-05, ID-08, MT-07, NM-23, NV-21, OR-33, UT- 26 and WY-06.

**The Diggings.com** is very user friendly. A name of claim name, the owners name or mine name can be entered into the search window and all the information involved with any of those names may be accessed from there. This information includes mineral types, ownership, years of production claims status etc. even some general geological information can be found in the reports on the individual claims. The information provided sometimes exceeds that found in LR2000 but as far as the claim status and location of the claim LR2000 is most up to date.

**Western Mining History** is an online resource that show lots of historic information in regards to mining towns and mines with the use of maps that are easy to navigate. The maps can be increased or decreased in size by scrolling with the mouse wheel and has a grab/drag feature to change places on the map. When a map is opened red dots will be seen denoting mining towns and black dots will appear denoting mines. By right clicking on the black dots the Mines name, state, county and the mineral of interest is displayed, clicking on the name of the mine opens information about the mine. Clicking on a red dot displays the towns name state, county and status, clicking on the town name will show an interesting history of the town. Several of the features are only available with a membership at the cost of \$29.

Every county has an website for their assessor's office in which ownership of property can be found.

### New meeting location for Desert Gold Diggers

Beginning with the membership meeting of February 4, 2020 the meeting will be held at 2160 N. 6th Avenue in Tucson at the Donna R. Liggins Recreation Center. It is located 2 blocks east of Stone Ave. just south of Grant Road. The meeting time will remain the same.

This move will give the club a savings of \$540 a year on fees to Pima County Parks Department. The director of Ellie Towne Community Center also re-ports that a renovation will soon be taking place and the facility closed for an undetermined amount of time.

It is a nice spacious facility with lots of parking and it is centrally located for easier access for especially with the upcoming closure of the Ruthrauff Road exit off of I-10.

#### Southwest Mining Towns: Paradise , AZ

Paradise Arizona in Cochise County sits about 5 miles west of Portal in the Chiricahua Mountains. Though prospecting began in the 1880's the town itself wasn't established until 1901, it's post office being established October 23<sup>rd</sup>. The town grew out of development work by the Chiricahua development company based out of Michigan. A double compartment shaft was sunk between 1901 and 1903 to mine a copper ore body that proved unprofitable. The company abandoned the project in 1905. Other mines in the area that operated after the demise of Chiricahua Developments project were the Leadville Group, the Columbia Mine and the Martin Claims. Some of them operated into the 1950's

The original jail was open air consisting of a chain stretched between 2 trees to which the prisoners were shackled, they were often chained to one of the trees. The need for enforcement was great as there were 13 saloons in the town.

Many of the houses in the town were moved in from Galeyville which met its demise in 1882. In June 2011, there were five permanent residents and 29 standing structures when the Horseshoe 2 Fire swept through the area.

#### Coronado's Children: Tales of Lost Mines and Buried Treasures of the Southwest


Even though none of the stories include Southern Arizona the writing of Frank Dobie is always interesting and engaging. Being written in the 1930's some of the stories are include 1st hand accounts of the happenings during the search for the mines and lost treasures before the turn of the century.

It is helpful to have a road atlas nearby or access to Google Earth so as you read a better idea can be gained about the area being described. Dobie gives good descriptions of the areas of which he wrote and in many cases gives different renditions of the same legend.

I found the last chapter a bit disconnected unlike the previous chapters. The entire book was

enjoyable however, whether using the book as a guide to one of the mines or treasures or just to spark they fancy of daydreams.

May 1, 1933 President Roosevelt enacted Executive Order 6102 requiring all persons to turn over all but a very small amount of gold coin, bullion and certificates in exchange for \$20.67/Troy oz.

He used the obsolete law of 1917 Trading With The Enemy's Act as justification. Violations were punishable with a \$10,000 fine and up to 10 years in prison.

Remember to drink plenty of water and always take more water into the field then you think you may need. Policy for firefighters is, "if you are thirsty you are already becoming dehydrated."
