Desert Gold Diggers Officer Positions & Duties

- 1. **President:** The principle executive officer of the club responsible for presiding over the membership meetings, signing contracts, deeds, or other instruments authorized by the Board of Directors. Presides over the meeting of the Board of Directors in the absence of the Board Chairperson.
- 2. **Vice President:** Arranges for the program or speaker at the monthly membership meetings and steps in for the President when the President in unable or unwilling to do his/her duties. *(Currently vacant)*
- 3. **Secretary:** Records the minutes at the membership and business meetings, prepares and sends notices under the bylaws and keeps the Corporate Seal for sealing official documents as directed by the Bylaws or Board of Directors.
- 4. **Treasurer:** Responsible for all funds and securities of the corporation. He/she handles the banking duties for the club and presents financial reports to the Board of Directors and may perform other duties from time to time as assigned by the President or the Board of Directors.

Desert Gold Diggers Officer Positions/Duties (continued)

- 5. **Board Members:** There are three classes of board members which include 1, 2, and 3-year positions. Board members are responsible for deciding the direction of the club and meet the third Tuesday of each month. Meetings seldom last over an hour.
- 6. **Outing Coordinator:** Arranges and directs the monthly outings and prepares the schedule of outings to be published in the bi-monthly Gazette.
- 7. **Historian:** Responsible for keeping the club records, including minutes, financial reports and copies of the Gazette. He/she also holds the clubs video library.

Desert Gold Diggers Board Appointed Positions

- 1. **Claims Director:** Coordinates and leads the search for potential areas in which to stake placer claims for the club. He/she is also responsible for filing claim paperwork and updating the claims packets to the members. (Currently vacant)
- 2. **Newsletter Editor:** Produces and distributes the bi-monthly Gazette.
- 3. **Public Relations Director:** A "Goodwill Ambassador" that disperses information about the club to the public.
- 4. **Membership Director:** Responsible for maintaining and updating the list of club members, taking the applications and payment of new members, and handling the renewal of memberships.
- 5. **Website Liaison:** Acts as an interface between The Board of Directors and the web creator to submit information for publication to the website. *(Currently vacant)*

NOTE: All Officer and Board positions are open for nominations. This will be a "self-nomination" process. If you are interested in <u>actively participating</u> as a Desert Gold Diggers Officer or Board member, please nominate <u>yourself</u> (not someone else) on the forms that will be provided at the February and March monthly membership meetings.

The following page contains the names of the 2024 Officers and Board members. All club members are eligible to run for Officer and Board positions; however, anyone with a felony conviction cannot hold a position in which money is handled according to Arizona State law.

The election of Officers and Board members will be conducted at the April monthly meeting. To emphasize Ralph's remarks—"get involved and help make a difference."

Meet Ed Madson - DGD Board Member

My name is Ed Madson. I was born in Cleveland, Ohio, raised in East Cleveland, and went to Ohio State University. Later, I got a mining degree from Colorado School of Mines and then spent 13 years overseas in the oil business. I moved to Tucson in 1982.

When I was 14, my father took the family on a trip to the Black Hills of South Dakota. This is where I first panned for gold. When I attended Ohio State University, I learned that there was glaciated gold in Ohio and Indiana, so I traveled there and found some flakes of gold and I was hooked! After I graduated from Colorado School of Mines, I changed careers and ended up overseas and had the opportunity to go prospecting in Ethiopia and Scotland.

When the price of oil collapsed in 1982, I moved to Arizona. I joined the Road Runner Prospecting Club in Phoenix and found a girl who would go dredging with me and my 3-inch dredge. Guess what— I married her!

In Tucson, I was a member of the GPAA and went with those who split off to become the Desert Gold Diggers. The first nugget I found was in Greaterville and was about 6 grams. The largest nugget I have ever found—THE FIND OF A LIFETIME— was from Yavapai County and weighed a little over a troy pound, more than 13 ounces!

I have been prospecting and found gold in Northern California, Northern Nevada, New Mexico, Alaska and Colorado. Back when there was water, I dredged in Arivaca, Greaterville, Morenci, Pinto Creek and Prescott. It seems like I always found gold back then. When my boys were younger, we made an annual trip to Northern California and always found some gold. Those trips finding gold are something they will always remember.

Metal detecting is what I do now; however, I'm just not successful every trip. Lately, I've been metal detecting mine dumps with some success.

My advice for our new club members is to always detect quartz rocks. They may be gold bearing. I found a 46 lb. rock that has multiple spots of gold on the surface. Who knows how much it actually contains!





Interesting Facts about Gold

In ancient Egypt, gold was considered the skin or flesh of the gods, particularly the Egyptian sun god Ra. Consequently, gold was unavailable to anyone but the pharaohs, and only later to priests and other members of the royal court. The chambers that held the king's sarcophagus was known as the "house of gold."



Between A.D. 307 and 324, the worth of one pound of gold in Rome rose from 100,000 denarii (a Roman coin) to 300,000 denarii (a 200% increase). By the middle of the fourth century, a pound of gold was worth 2,120,000,000 denarii—an early example of runaway inflation, which was partly responsible for the collapse of the Roman Empire.




Paydirt for Sale

Gold Price Trend: October 1, 2024 - January 24, 2025

The price of gold the past 90 days have been very volatile, ranging from a high of \$2,805 an ounce on October 30, 2024, to a low of \$2,582.80 on November 15, 2024. The November election, economic uncertainty, and geopolitical activity are the main factors that continue to affect price volatility.



Mining History of the Tucson Mountains

The Tucson Mountains are a range of mountains 25 miles long and 10 miles wide, with Tucson located at the east base of the central part of the range. The Tucson Mountains have over 200 prospector pits, abandoned mines, and numerous mining camps scattered throughout its range. Many of the trails in the Saguaro National Park and Tucson Mountain Park were once mining roads. Five of the more prominent mines are accessible from marked trails and often visited by hikers. Some of these, such as the Old Yuma Mine, have storied histories that include kidnapping and embezzlement.

The Old Yuma Mine was the most successful mine in the Tucson Mountains. The original claim dates back to 1872, and it was the last mine in the area to close in 1947. Copper, silver, gold, and other commodities were mined from this location. During War World I, Molybdenum (used for hardening steel) was mined, and the owners added a mill and smelter, which ran until 1920. Attempts to reopen the mine in the 1980s failed because of legal battles, and Saguaro National Park acquired the property in 2001.

The mine is better know for its museum-quality, orange-red wulfenite crystals and an exciting kidnapping that occurred in the early 1930s. In 1932 Cliff Adkins kidnapped Tucson banker Gordon Sawyer for a \$60,000 ransom. The local deputies were able to track the abductor and rescue Mr. Sawyer from an abandoned well at a local ranch. However, Adkins escaped and hid at the Old Yuma Mine, forcing the owner, "One-Eyed" Joe Baker, to feed him. Mine caretakers reported Atkins to

authorities, and the Tucson Police and Border Patrol eventually apprehended the kidnapper.

If you want to walk to the Old Yuma Mine, start at the Picture Rocks Wash Trailhead located on W. Picture Rocks Rd. Hike 1.4 miles south to the intersection of Ringtail Trail. Move off trail to the southeast for .5 mile to the mine. Round trip 3.8 miles.

WARNING! Abandoned mine sites are a GREAT safety hazard. Dangers include old explosives, hazardous chemicals, bats, bees, snakes, spiders, bobcats, mountain lions, and other predators. Falls and cave-ins are common. Entry into these mines is prohibited and strongly discouraged.



Supergiant Gold Deposit Discovered

A deposit of high-quality gold ore containing around 1,000 metric tons (1,100 US tons) of the precious metal has been discovered in central China, according to Chinese state media.

Valued at approximately 600 billion yuan, or US \$83 billion, the discovery could be considered the largest and most lucrative reservoir of gold ever uncovered, surpassing the 900 metric tons estimated to lie within the mother of all gold reserves, South Deep mine in South Africa.

The Geological Bureau of Hunan Province announced the detection of 40 gold veins within a depth of 2 kilometers (1.2 miles) in the northeast Hunan County of Pingjiang.

Core samples showed visible gold and suggest every metric ton of ore could contain as much as 138 grams (nearly 5

ounces) of gold — an extraordinary level of quality considering ore excavated from underground mines is considered high grade if it contains more than 8 grams per metric ton. Additional core samples taken around the periphery of the Hunan site hint that the deposit may extend even further than initial predictions, making the reservoir beneath its soil a true dragon's haul.

China already dominates the world's gold market with reserves considered to be in excess of 2,000 tons earlier in 2024, its mining industry contributing around 10 percent of the global output.

Announcements of the findings have contributed to a further increase in the already skyrocketing gold price as demands for the resource continue to rise amid global uncertainty. This discovery is expected to boost China's already significant influence in the global gold market. The country holds more than 2,000 metric tons of reserves and contributes about 10% of the world's gold production.

Forged in the furnaces of embracing stars long before Earth was formed, our planet's glittering veins are a finite resource that take eons to precipitate into an easily mineable form. Just how many bonanzas of the valuable ore remain yet to be discovered around the world is unclear, with experts divided on whether we've reached peak gold.
