# **October Overnight Outing Information**

# **Outing Director's Report: August 10 (Wishful Claims)**

Our Sunday, August 12, 2025 outing started by meeting at the Buenos Aries Wildlife Refuge pull-off on the south side of Arivaca Road at 7 AM. There were 20 members that signed in and caravanned to the metal detect hunt site.

I hid 24 \$1Peso targets: three (3) for gold nuggets; three (3) for \$2 bills; and 18 for \$1 coins. All targets except one were found.



After the metal detector hunt, members headed out to the Wishful 1 claim to mental detect and prospect, using different recirculation setups and drywashers.

It had rained lightly overnight and it was overcast and the weather was very nice. Members were finding some nice color cleaning off some of the bedrock in different areas of the claim.

The next outing will be at Bruiser claims in Oracle on September 6. We will meet shortly before 7 AM in the dirt parking lot just west of Circle K.

Our September 7th outing started when club members met at 7 AM at the dirt parking area across from the Circle K in Oracle. Copies of the Notice of Intent (NOI) acceptance letter from the Forest Service were distributed to all members that planned on prospecting on the Bruiser Claims.



It was a cool and overcast morning. We caravanned to the detector hunt site where I hid 24 nickel targets consisting of 18 targets for \$1 coins, three (3) for \$2 bills, and three (3) for gold nuggets.

The \$2 bill winners were John Babcock, Max Offermann, and Daniel Manning. Gold nugget winners included Cris Lespron, John Babcock, and David Doyle.

After the detector hunt, club members headed up to Bruiser 2 and 3 to begin prospecting. Members were finding nice color with a couple with nice chunky pieces. It remained overcast and was a very nice day and members began to leave around 2 PM. Some board members and president Ralph Montaño performed some road maintenance and picked up lots of trash and filled in holes.

It was a great day to be out prospecting. The next outing will be the October fall overnight outing October 10-12 in Gardner Canyon. Keep finding that shiny!

# Membership Meeting Minutes: August 5, 2025

- Ralph Montaño convened the meeting at 6:04 PM; opened with the Pledge of Allegiance; he introduced new members and guests; asked who was celebrating birthdays and anniversaries in August; asked if anyone knew of anyone that needed to be included in the MASH report.
- Darrell announced the next outing is Sunday, August 10, at the Wishful claims south of Arivaca; members should meet at the Buenos Aires Wildlife Refuge trailhead parking lot east of Arivaca at 7 AM; detector hunt will be for pesos.
- Ralph introduced the quest speaker, William Oppenheimer, RG Geologist M3 Consulting & Management. He spoke about three prospecting approaches that resulted in the discovery of the four biggest bonanza mines since the 1970s in North and South America (Escondido, Chile copper; Ekati, Canada - diamonds; Barrick & Sleeper, Nevada -gold). He also provided some interesting information regarding gold in the Greaterville area.
- Ralph briefed the club regarding recent positive discussions with the Forest Service about the club's claim renewals. He reported that the Forest Service will be issuing ID's for members to have while working on our club's National Forest claims. The club will report when the ID's will be distributed. Club members will still be required to carry DGD issued ID's when working on our claims. Forest Service staff will be periodically checking our claims during future monthly outings. Remember to bury your prospect holes when you leave. A reminder to NOT use vacuums to clean out your

- prospect holes as discussed at past meetings.
- Applications for claim renewals with BLM are ongoing. Board Members are continuing to investigate opportunities and options for filing additional DGD claims.

# Membership Meeting Minutes: September 2, 2025

- Ralph Montaño convened the meeting at 5:58 with the Pledge of Allegiance; introduced new members and guests; asked about any September birthdays/ anniversaries and provided the Mash report.
- Next outing is Saturday, September 6 at the Bruiser claims; members will meet at the Circle K and depart at 7:00 am to drive to the detector hunt area; the detector hunt will be for 24 targets; after the hunt, members will proceed to the claims. Ralph requested that members arrive 15 minutes before 7:00 to ensure that everyone can get directions to the outing.
- Ralph introduced Claims Director Hank Bassaraba who provided a detailed and informative presentation regarding the Club's Forest Service Notice of Intent (NOI) placer claim renewals. He noted that the NOI will now be reviewed annually. His presentation specifically focused on the Club's NOI Bruiser 2 & 3 claim submittal, which has been approved. He discussed required claim renewal information including: legal description, serial location number, coordinates, map, claim ingress & egress, and other site information including club outing information such as outing schedule, location, proposed activities, projected number of participants. Clean up measures were also presented to the Forest Service. While over 95% of the NOI requirements are unchanged Hank highlighted several new requirements.
- Hank reported that the Forest Service will be issuing NOI Approval Letters for members to have while working on the Club's National Forest claims. The Club will provide approval letters to members when they become available. Ralph indicated the plan is to e-mail club members the Forest Service Approval Letters so that members can make copies to carry with them. Paper copies will be mailed to members who do not have access to e-mail. Club Members will still be required to carry DGD issued ID's when working on our claims. Forest Service staff will also be periodically checking our claims during future monthly outings and may be at the Bruiser claim outing.
- Hank also reported that the Forest Service specifically noted that cutting down trees is not permitted (which is also a club rule). This requirement, in part, is to protect bird nesting habitat for a Federal endangered species, the Yellow-billed Cuckoo. Hank and Ralph concluded the presentation by noting the Forest Services concerns about preventing the spread of invasive plant species, and the protection of historic and archaeological remains. Hank indicated the Forest Service will review the Hope and other Club claims in sequence. A question and answer session followed. Ralph reiterated the importance of burying your prospect holes when you leave and to follow other club, Forest Service, and BLM rules.

# **Business Meeting Minutes: August 26, 2025**

- Chairman David Fuller convened the meeting at 6:31 pm.
- Secretary's Report: Ray read the previous minutes. Joe moved to approve, seconded and approved.
- Gazette Editor's Report: Ray requested stories for the next issue of the Gazette and suggested that stories about members recent trips to Colorado would be of interest to club members. # Coatimundi Sighting on Bruiser!

During the September 6 outing at the Bruiser Claims, Becky Marihugh spotted a coatimundi (also known as coati) roaming around the claim. Several club members were working on the claim below Bruiser 2 when Becky saw a long bushy tail go past about 20 feet away. She mentioned to her husband and to Cris Lespron that she just saw a "coati." About a minute the coati came up over the hillside and was in full view. Becky stated "the coati went around us staying higher on the hillside, then he continued on up the wash towards the Bruiser claims. He came back about a hour later and that's when he actually hung out letting David Fuller and I get as close as 5 ft."

In Arizona, coatimundis inhabit the Superstition Mountains east of Phoenix and the Huachuca Mountains southeast of Tucson. Coatimundis sleep in trees and prefer elevations of

4,500 to 7,500 feet, but they occasionally travel to lower deserts in winter.

If you keep your eyes open while on the Bruiser claims, you may just get a glimpse of Becky's coatimundi!

### Filing a Notice of Intent with the Forest Service

During the last week of April 2025, DGD President Ralph Montaño, Claims Director Hank Bassaraba, and board member Grady Dees met with Dan Moore of the Bureau of Land Management (BLM) and Manuel Silva of the Forest Service (FS) in Tucson. The purpose of the two meetings was to inquire what Desert Gold Diggers needed to do, if anything, to ensure that all DGD claims are in compliance with all rules and/or regulations since our claims are on both BLM and FS land.

In the Forest Service meeting with Manuel Silva, the Forest Service informed DGD that a Notice of Intent must be filed annually for each of our claims on Forest Service land, which includes the Bruiser, Hope, Placer Pond, and Wishful claims.

So why is a Notice of Intent required by the Forest Service? Per the Code of Federal Regulations, 36 CFR 228.4(a), states that a notice of intent to operate is required from any person proposing to conduct operations which might cause significant disturbance of surface resources. Such notice of intent to operate shall be submitted to the District Ranger having jurisdiction over the area in which the operations will be conducted. Each notice of intent to operate shall provide information sufficient to identify the following:

- (1) the name, address, and telephone number of the operator
- (2) the area involved
- (3) the nature of the proposed operations
- (4) the route of access to the area of operations, and
- (5) the method of transport.

On August 27, the Forest Service notified DGD that the activities proposed in the NOI for the Bruiser Claims would not likely cause a significant disturbance of surface resources, therefore, a Plan of Operations was not needed at this time. Desert Gold Diggers expects to receive NOI approval/acceptance letters for the Hope, Placer Pond, and Wishful claims by the end of the calendar year.

As of September 1, 2025, we are pending responses from the Bureau of Land Management regarding Pilgrim's Pride #1 and #2 claims along with Snoozin claims #1 thru #5 with the Location Notice For Placer Ming Claim Form-MCF102, revised Oct. 2018.

Thanks to Hank Bassaraba and Grady Dees for working through this process with the Forest Service and the Bureau of Land Management.

### **Operating Instructions for DGD Claims**

All Club members who prospect on the DGD claims owned and/or controlled by the Desert Gold Diggers, Inc. Club, must comply with all of the provisions contained within this document. Failure to follow these instructions could result in the removal of the violating member from all Club functions and possible legal actions by the appropriate government agency. (The following instructions were revised September 18, 2025)

#### **Instructions for all Members:**

Disclaimer: Prospecting and prospecting locations can be dangerous with numerous natural and artificial hazards. Desert Gold Digger members and/or guests agree to release the Desert Gold Diggers, Inc., their officers or assignees and or private property owner(s) from any liability incurred during prospecting ventures.

GUESTS are allowed to accompany a member **ONE TIME** during A SANCTIONED Club outing on a claim. Those guests wishing to go again must join the Club. Members are responsible to ensure all guests abide by the DGD club rules and Operating Instructions.

You are required to have the following with you when you go prospecting on any of the DGD claims: Name badge, current membership ID card, the current DGD Club Operating Instructions and current Notice of Intent (NOI) for the applicable claim. PLEASE WEAR OR DISPLAY YOUR DGD NAME BADGE AT ALL TIMES WHEN ON THE CLAIMS. The Forest Service has specifically asked that the name badge be on display. The Forest Service has also asked that we make contact with other users of the DGD Claims.

If you see someone digging on a DGD claim that you don't recognize, please ask to see their name badge and current membership ID card. If they are not a member, politely ask them if they would like to become a member. If so, direct them to the current Membership Director, Club President, and/or the website for club application information. REGARDLESS OF THEIR INTEREST, they should stop digging. As a non-member they have not signed the DGD Club waiver/disclaimer. If they refuse to stop digging, DO NOT argue with them. We would appreciate your contacting the Chief Claim Steward or the Claims Director with all the pertinent information (date, time, license number, etc.).

DO NOT be offended if a BLM, Forest Service Ranger, other government official, or DGD Club Member asks for your identification. If being cited or citation is being threatened, get the badge number and name of the Official along with the regulation number being violated. Please give the information to the Claims Director for further review.

Please observe all of the National Forest Service and BLM rules and regulation regarding trash and fire restrictions. Be a responsible member by maintaining trash control on and off the DGD Claims.

### **Operating Instructions for DGD Claims** (continued)

Member violations of our Operating Instructions on National Forest land could be cause for the cancellation of our claims, thereby ending our prospecting. Please observe all federal and state regulations relating to prospecting on National Forest or BLM land.

#### **Rules for ALL DGD Claims:**

- Reclamation will be ongoing in the course of this operation. Excavations will be no greater than a 3' x 3' x 3' hole and will be filled in before a member moves to another area and before a member leaves the claim area. All back filling will return the wash or embankment to its natural elliptical shape. It is understood that, although an individual may be planning a return trip to the claim area sometime in the immediate future, no excavations will be left open and unattended even for the matter of hours or a few days.
- Any activities on a Forest Service claim beyond that described on the Operating
  Instructions will require a Notice of Intent (NOI) be filed with the appropriate District
  Ranger. Please read the operating Instructions so that you are familiar with the types
  of activities you can perform on a claim i.e. dry washing, panning, using re-circulating
  sluices etc.
- The operation will be limited to the use of recreational prospecting equipment. NO explosives or mechanized earth moving equipment will be used.
- All water from high bankers must be discharged onto the bank to reduce turbidity in the stream.
- Overburden must be removed from the embankments to eliminate any safety hazard in lieu of undercutting. Bank must be returned to natural contour prior to leaving claim.
- You cannot go out to a claim and dig up buckets of dirt to take home. You should
  complete the act of producing concentrates at the claim so that the only thing you
  take away is the concentrates and all other dirt is placed back in the hole.
- All combustion engines will be equipped with an approved spark arrestor prior to operation on any DGD claims. Fuels and lubricants will not be disposed of within the DGD claim site or on government land. They will be taken to an approved disposal site.
- When fueling, combustion engines must be placed in plastic containers of at least 10 mil gauge to prevent leakage and spillage contaminating the ground. If a spillage should occur, the contaminated soil should be dug up and resulting hole backfilled. The contaminated soil must then be taken to an approved disposal site.

#### **General Information**

Reference maps are photo copies of U.S. Geological Survey Maps (topo maps). Some
of the copies may use a combination of two or more topo maps that were put together
to depict the general area. It is suggested that you become oriented to map reading
and obtain specific topo maps of the DGD Claims you wish to prospect. Laminated
maps depicting groups of DGD Claims may be available from the DGD Club store.

### **Operating Instructions for DGD Claims** (continued)

#### **General Information** (continued)

- Major starting points and directions are given. Because of the limited page space all road information may not be portrayed.
- All DGD Claims, i.e., corner stakes, location notices and signs, will be identified. In some cases these posts are destroyed or removed by non-members. Please advise the specific Claim Steward, the Chief Claim Steward or any of the DGD Club Officers of missing posts or signs. A list of these people can be found in the DGD GAZETTE or on line at: www.dersertgolddiggers.com.

### Forest Service NOTICE OF INTENT Requirements

The following are the latest <u>Forest Service NOI requirements for DGD claims in the Coronado National Forest.</u> It is understood and agreed by all members that the Notice of Intent (NOI) requirements are considered to be part of the General Information and Operating Instructions for DGD claims as described on pages <u>14-16.</u>

The Forest Service has made the following requirements that pertain to each claim, but could also apply to other claims as well:

#### Bruiser 2 and 3:

- No tree removal on these claims since they are near Yellow-billed Cuckoo habitat (an endangered species). Minimal branch trimming is allowed for claim maintenance.
- To prevent/minimize the spread of invasive plants, members are responsible to ensure clothing, equipment and vehicles are clean, free of seeds, soil, plant material or other debris prior to arriving at the claim.
- Placer mining activities are to be conducted within the current and historical stream beds.
- If any discoveries of historical artifacts or archaeological remains are found, cease activity and advise any of the DGD Club Officers or Claims Director and they will notify the Coronado National Forest Archeologist.

#### **Hope 1-4:**

- Hope claims 1 and 4 are in a National Register Historic District (Kentucky Camp and Greaterville Mining Districts), so members are to stay within the flood plain and off of the terrace to help protect those features.
- If equipment makes contact with water, disinfect equipment with mild bleach solution (e.g., diluted quaternary ammonium) between different water sources to prevent spread of amphibian pathogens (chytrid, ranavirus).
- Minimize trampling of stream banks and riparian vegetation.






than us, but we all walked away with gold—no skunks here! There was this beautiful stellar jay that took a liking to us and followed us around all day.
