Southwest Mining Towns

Charleston/Millville

A typical problem in the mining industry is water for processing the ore. Pumping technology was before the turn into the 20th century was weak at best causing the need for mills to be built along streams. This situation gave the rise to Charleston, Arizona on the west banks of the San Pedro River and Milltown on the east bank. 2 stamp mills were set up in Millville, one operated by tombstone Milling and Mining, the other by Corbin Milling and Mining.

The mill sites stayed on the East bank of the San Pedro River as the sand in the creek bottom was so soft the ore wagons couldn't cross it and there was substantial quicksand in the area. When the sites for the mills was decided upon Amos Stowe took out a claim in October of 1878, using the Homestead Act rules, on the land which was to become Charleston. Stowe was wise in the development of the townsite, meticulously laying out 26 blocks of 16 lots each, he made such good leasing options there were 40 buildings and a post office within six months. The town of Charleston was named after the postmaster, Charles Handy, Millville also had a post office but shut down after about a year as it was apparent the main residential area would be Charleston.

Justice of the peace, James Burnett, after a disagreement with the Cochise County Board of Supervisors declared a sort of sovereignty of court dealing out justice immediately upon his decision. His fines included the confiscation of livestock to chopping large amounts of firewood. Burnett was a dictator of sorts until the town's demise in 1889, some stated because of his forceful influence Charleston was one of the most peaceful towns in the area.

The Sonoran Earthquake on May 3rd 1887 along with its aftershocks brought to town to ruins destroying every adobe structure in the area. Along with the demise of the mines in tombstone due to flooding the mills closed and the Post Office shut down October 24, 1888. Much of the wood that remained was scavenged as firewood. Soldiers from Fort Huachuca did some urban warfare training at the Charleston site during World War II, referring to the site as Little Tunisia due to the local climate. Little can be seen of the townsite today as the San Pedro has taken much of it away due to erosion.

There are rough trails that lead to the townsite of Charleston along the river from Charleston road about half way between Tombstone and Sierra Vista. It is said the BLM has begun some improvements to the trails.
